DEPOSIT: Deposit is 50% of your total price or \$150 deposit (whichever is less) and is required to confirm your reservation. Deposit will be applied to your balance.

CANCELLATIONS: Cancellations are due in writing at least 2-weeks in advance for deposits to be refunded minus a \$25 administration fee. Failure to comply with cancellation/reschedule procedures would result in payment due in full per invoice. Rescheduling due to inclement weather does not constitute "cancellation," however, groups wanting to reschedule due to inclement weather must notify Sensing Nature by phone at (727) 327-1345 at least 2-hours prior to scheduled arrival. Otherwise, cancellation procedures will apply.

PAYMENT DUE: Full payment is due on or before the day of the field trip, or on the first day of multiple day field trips. Checks made payable to "Sensing Nature" or credit card payments accepted. No P.O.s accepted.

Changes in Participant Numbers:

- Additional students/paying adults would be subject to additional applicable per person fee.
- Reduction in 1 to 2 Paying Participants: A small change up or down (1 to 2 people) the day of the scheduled field trip is okay, however, group size reductions may change your group fee for that option into a higher price per participant category.
- Reduction in More Than 2 Paying Participants: Please provide in writing (email or postal) at least 7 days in advance of the field trip if your group will be missing more than 2 paying participants. Otherwise, your group will be invoiced for the number of participants we were previously requested to guide.
- Our minimum number for a field trip is 10 participants per Option, so if your participant number drops lower than 10 paying participants for one of the Options selected, the minimum fee is for 10 participants per option.
- Number of free chaperones may change if you have fewer youths participating than expected. 1 free adult chaperone per 10 paying participants.
